Keynote Address: Context Based Complete Streets - History and Policy. Richard Hall shares the history of urban design and street design when traditional streets and highways adjusted to the industrial revolution, motor vehicles and Modernism. Understanding the past is vital when the future challenges us all and street designs play a vital role in shaping the urban environment.

The Planning and Zoning Officials Guide to Pot, Poles, Pistols and Human Trafficking Defensive Zoning. Examine the status of Ohio laws on medical marijuana, small cell facilities in the right-of-way, and open and concealed carry in public places, and discuss land uses that could involve human trafficking and how zoning code regulations could be used to deter such trafficking.

Establishing a Community Vision through Public Engagement. Explore the public engagement process used for the Deerfield Township Parks Master Plan, the outcomes derived from this successful process, and the conceptual plans designed for the former Kingswood golf course.

How to Utilize Community Improvement Corporations and Land Banks to Benefit Your Community. Hear about the creation and operation of Community Improvement Corporations and county land banks and how they can be utilized to assist with the issue of tax-delinquent properties.

Local Food Organizations and the Governance of the Urban Food Systems. Learn about urban food entrepreneurship in the greater Dayton region, the roles that local food organizations play in our food systems, and how to further encourage food entrepreneurship.

Fair Housing Best Practices for Municipalities. Review fair housing obligations in the areas of planning, zoning, and building inspection. The civil rights obligations for HOME funds, CDBG funds, HOPWA, and entitlement funds to combat homelessness will also be discussed.

Context Based Complete Streets - Key Design Elements. Join Richard Hall as he explores in more depth specific design elements of complete streets and how they vary from rural to urban contexts. Specific dimensions or character of selected street/highway elements are presented.

Planning for Sustainable Interchange Development: County Road 25-A Special Planning Area Master Plan. Review how land surrounding an interchange can be developed in phases to accommodate appropriate land uses while following sustainable growth practices.

Historic Preservation and Zoning. Many zoning ordinances reference The Secretary of the Interior's Standards for the Treatment of Historic Properties as the standard for the renovation of buildings in historic districts. Learn what it means in practical terms to reference these standards.

Make it Count -- 2020 Census Efforts in the Miami Valley. This session will highlight changes to the 2020 Census, provide information on what to expect regarding the Census, and explain what communities can do to make sure their residents are accurately and completely counted.

USPS Centralized Deliveries and the Informed Delivery Program. Understand the United States Postal Service policy concerning Community Box Units and the new program of Informed Delivery as it relates to centralized delivery.

There's an (GIS) App-lication for That. Explore how GIS can be used to improve the decision-making process and how GIS applications were created for the unique needs of Great Miami Riverway, Montgomery County Land Bank, and the Dayton Riverfront Master Plan.

Context Based Complete Streets - Design Examples. Richard Hall shares examples on how defining the context of areas surrounding transportation thoroughfares (existing and future areas) allows street designers to focus on specific design elements suited to that rural, suburban or urban character and development pattern.

Get a Move On - Providing Transportation Access. Learn how transportation options for seniors, the disabled and low-income individuals are being improved by the Senior Transportation Enhancement Program, Human Service Transportation Coordination Plan update, and the Greater Regional Mobility Initiative.

The Cooperative Model: A Strategy for Equitable Economic Development. Hear how worker ownership in places like the manufacturing sector and cooperatives such as the Gem City Market can provide sustainable and equitable economic development for the region.

You Gotta Plan - It's Electric! Boogie Woogie Woogie. The future is electric. This session will review recent trends in the world of light electric vehicles and how your community should plan for them.

Sparking Revitalization in Retail Corridors. What is the spark that drives redevelopment in struggling urban corridors? This session will focus on the necessary ingredients to building successful retail corridors in urban neighborhood corridors.
